### 179/79) Brylaine K59 bus service reduction (MB)

A discussion took place led by Cllr M Brooks regarding the reduction in the service and the points made in the public forum. Points raised were:

- Reduction of 1 hourly service to 2 hourly.
- Possibility of diverting some of the direct services through Swineshead to share the cuts.
- Difficulties faced by people with Doctors/Hospital appointments or those working in Boston with no other means of transport
- Doctors surgery that services surrounding villages
- The limit that the County Council can pay due to the deminimus level of their subsidy, currently they pay for the Saturday service
- Commercial aspect of the service for Brylaine, however Swineshead is a growing village and for people to come to the village a good service is needed.
- Call Connect service

It was resolved that the Council would protest strongly to Brylaine, Boston Borough and County Council to look seriously at improving the service and a letter be sent to Boston Borough Council, Lincolnshire County Council and Brylaine and then invite them to attend a Parish meeting.

It was also resolved to make people aware of the Call Connect service via the village Magazine, website and facebook

**ACTION**: Clerk to write to Brylaine Bus Service, Lincolnshire County Council and Boston Borough Council protesting against the change and raise the points discussed in the meeting. Clerk to advertise the Call Connect service on facebook and the website.
