B/17/0244 – Outline application for 41 affordable dwellings , Woods Nurseries Site, High Street.

An Increase from 38 to 41 in application, however the application is still at the outline stage, and this application has good visibility at the access road, It was resolved that there were no comments or concerns.

B/17/0404 – Amendment to erection of 74 dwellings on Coles Lane.

This application goes deeper into the drainage than the previous one and how it flows into the current system. It was resolved that due to apologies for absence, and declaration of interests this item was not Quorate so no comments could be made, however previous comments still stood on this application

161/17 Councillors reports.

Cllr MB has received a complaint from Abbey Crescent of people parking on the footpath. This has reported to the police.

Cllr KO report witnessing the incident that has bend the railings around the memorial and this has been reported to the police although no response has yet been received, following this CCTV from the local shop has been seen and identifies the vehicle. It was resolved that Cllr KO would contact the police again and obtain a crime no.

Cllr KO gave feedback from the planning training session he attended. There were two items of interest, the categories of planning and the list of material items. In addition he discussed the fact that the local development plan does not come into force until next year meaning there is nothing to object against. Even when it comes in the assumption on planning now something will be permitted there is a presumption in favour if sustainable.

Cllr KO raised comment about street lights out on Abbey Road. The Clerk confirmed that a report for one had been made to Highways, however it was pointed out that these were under the Parish Council and that Boston Borough was responsible for repairing them. It was resolved that the clerk would make a report to Boston Borough Council.

Cllr JB reported that Blackjack Road was experiencing standing water on the road side when it has rained from the A52 to Kirton End. It was resolved that the Clerk should report this to highways.

ACTION: Clerk to report standing water on Blackjack Road to Highways Dept. Clerk to report Abbey Road light to Boston Borough Council. Cllr KO to contact police in follow up to initial call.
